**Counselling for admission to MD/MS/MDS Courses in all Government/ Government Aided/ Private Unaided Medical/ Dental Institutes including those under Private Universities - SGT University, Budhera, Gurugram, PDM University Bahadurgarh, Jhajjar in the State of Haryana for the Academic Session 2019-20.**

It is for the information of all the eligible candidates desirous of seeking admission to PG (MD/MS/MDS) courses for the academic session 2019-20 and all other concerned that admission to PG courses for the academic session 2019-20 shall be conducted through an Online Combined Centralized Counselling in all Government/Government Aided/Private Unaided Medical/Dental Institutes including those under Private Universities i.e. SGT University, Budhera, Gurugram and PDM University, Bahadurgarh in the State of Haryana on the basis of merit list prepared as per the marks obtained in the NEET PG 2019 and NEET MDS 2019 conducted by National Board of Examination (NBE).
